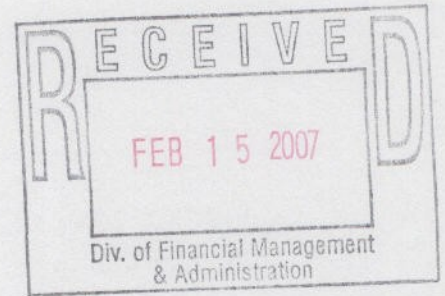

Budget Amendment No. 2
An Ordinance Relating to the Annual Budget and Amendment Thereof

Whereas, the Fiscal Court of Spencer County, Kentucky has realized unbudgeted receipts in the General, Road, and Jail Funds,

Be It Ordained by the Fiscal Court of Spencer County, Commonwealth of Kentucky:

Section One: The budget for fiscal year 2006-2007 is amended to:

A. Increase the receipts of the General, Road, and Jail Funds by \$752,423.00 to include unbudgeted receipts from:


