

SPECIAL MEETING SPENCER COUNTY FISCAL COURT

- On the motion of Esq. Goodlett, seconded by Esq. Davis, with all members of the Court present voting "Aye", except Judge Karrer and Esq. Cheek, who were absent, it is hereby ordered to have Esq. Judd serve as moderator for the special meeting of Fiscal Court.

A. Prayer

Esq. Judd led the Court in prayer before Court began

B. Pledge

Pledge of allegiance to the American flag

C. Call to order by Esq. Judd

D. Roll call by Spencer County Clerk, Lynn Hesselbrock- Judge Karrer and Esq. Cheek absent, quorum present.

Esq. Judd stated that as moderator he had a few conditions for conducting the meeting as he did for any other meeting. He said that people were welcome to speak, but that they must stick to the items on the agenda, and that they must not speak loudly or out of turn.

- On the motion of Esq. Moody, seconded by Esq. Davis, with all members of the Court present voting "Aye", except Judge Karrer and Esq. Cheek, who were absent, it is hereby ordered to declare null and void the termination of Building Inspector, Steve Clark.

Esq. Judd said that Esq. Davis had said that he had spoke with Mr. Rich Ornstein, an attorney with KACO, who said that the Judge did not have the authority to terminate Mr. Clark. Esq. Davis said Mr. Clark should be reinstated with keys to his vehicle, his office and with back pay. Esq. Davis then read from the Spencer County Administrative Code concerning the termination of an employee. He also referred to a KRS.

Mr. Doug Williams, the County Treasurer, said to the Magistrates that the action they were taking was the same as they had taken early in the new Court's term of office.

At this point, Esq. Judd asked if anyone from the audience wished to speak. He reminded them that their statements needed to pertain to Mr. Clark's termination only.

Mr. Trevor Brown addressed the Court with the concern that the Building Inspector needed to have a clear description of his duties and hours of work, noting Mr. Clark had often come out to job sites at odd hours if his services were needed.

Mr. Bobby Smith addressed the Court and apologized for his actions on the previous Friday. He then began to speak on the Building Codes when Esq. Judd reminded him that his comments needed to pertain to the agenda item. Mr. Smith said he would speak to the Magistrates after the Court ended.

Mr. David Jewell thanked the Court for taking the action to reinstate Mr. Clark.

Mr. Carl Darnell spoke to the Court about the County's Administrative Code.

Mr. Mike Driscoll stated that Mr. Clark had worked hard to keep the County's builders on schedule and had worked well with them in the past.

Mr. Gary Kehne stated that the County needed a Building Inspector, and that Inspector needed to be Mr. Clark.

- On the motion of Esq. Moody, seconded by Esq. Goodlett, with all members of the Court present voting "Aye", except Judge Karrer and Esq. Cheek, who were absent, it is hereby ordered to adjourn this special meeting of the Spencer County Fiscal Court at 1:16 pm.
